
Thank you for filing your alteration of rules. The alteration has now been registered.



The Annual General Meeting shall be held once every year between **1 November and 15 December**. The Committee shall determine when and where the Club shall meet within those dates.


Clause 22.6 is amended to:

Motion to changes to the rules as follows;

Clause 22.2 Shall be amended to;

Clause 22.2 The Annual General Meeting shall be held once every year between **1 November** and **15 December**. The Committee shall determine when and where the Club shall meet within those dates.

Clause 22.6 Shall be amended to;

Clause 22.6 No Club Meeting may be held unless at least **10 percent** of the Club Members attend.

The reasons for the amendment is as follows;

- 1. Currently we have 170 members, to hold an AGM under the existing rules require a minimum of 50 members to be present changing to 10 percent would be a realistic number for attendance.
- 2. To hold the AGM following the Club Prize-giving will give the opportunity to get the required attendance.
